In accordance with the EU Directive 2014/68/EU (PED), permission is herewith given to use identification no. 0200 when CE-marking under Module C2 for the types of pressure equipment mentioned in the Annex of this agreement for manufacturer:

The manufacturer is responsible for calculation, design and manufacture, performance of the final assessment, issue of conformity declaration and affixing of CE marking.

FORCE Certification A/S carries out unexpected visits in order to supervise the manufacturer's performance of the final assessment. During these visits, FORCE Certification A/S will:

- establish that the manufacturer actually carries out the final assessment in accordance with section 3.2 of Annex I of the directive
- at the manufacturing or at the storage premises take samples of the pressure equipment in order to conduct checks. FORCE Certification A/S assesses the number of items of equipment to sample and whether it is necessary to perform or have performed all or part of the final assessment of the pressure equipment samples.

Number and frequency of the unexpected visits depend on the type, number and rate of manufacture of the equipment.

To enable FORCE Certification A/S to perform the above inspection the manufacturer undertakes to:

- put the technical documentation for the types of equipment mentioned in this agreement at FORCE Certification A/S's disposal to an adequate extent
- report every change/modification of these types
- inform FORCE Certification A/S about production plans and terms
- give FORCE Certification A/S access to examine production, inspection, testing and storage facilities to an extent sufficient to let FORCE Certification A/S carry out the required inspection
- state serial number/identification number of all equipment included in this agreement.

The conditions given in FORCE Certification A/S, ABC - EU directives 6th edition – January 2019 are an integral part of this agreement.

Complaint about a decision made by FORCE Certification A/S shall be addressed to FORCE Certification A/S within 4 weeks after the decision.
