Should you, against all expectations, experience a problem with the Products (as defined below), you will find that Danfoss A/S, Nordborgvej 81, DK-6430 Nordborg, Denmark, offers a manufacturer's warranty (hereinafter the "Warranty") as set out below

#### 2. Duration of the Warranty

The Products are covered by this Warranty for a period of 5 years from the date of purchase by the first original end user customer, however never exceeding 66 months from the date of manufacture of the Product (the "5-year warranty period").

If you have purchased a Danfoss Icon2<sup>™</sup> system consisting of a Danfoss Icon2<sup>™</sup> main controller and Danfoss Icon2<sup>™</sup> thermostats: If you have purchased a Danfoss Icon2<sup>™</sup> system, and provided a professional installer installs the Danfoss Icon2<sup>™</sup> system, and uses the Danfoss Icon2<sup>™</sup> app to configure the Danfoss Icon2<sup>™</sup> system and create a handover-report in the app, then the 5-year warranty period only starts from the date of creation the first handover-report, however never exceeding 66 months from the date of manufacture of the Products.

System Warranty: When mechanical TRV sensors - listed in section 1 above - are installed together with RA-DV, RA-N or RA-U valves, the 5 years warranty for these specific TRV sensors and valves is extended to a total of 10 years from the date of purchase by the first original end user customer, however never exceeding 10 years and 4 months from the date of manufacture of these specific TRV sensors and valves. We call this System Warranty. To obtain the System Warranty the professional installer, who installs the specific TRV sensors and valves must fill-in and sign the document attached hereto as Annex 1. This document together with the installer invoice clearly specifying the TRV sensors and valves must be presented to Danfoss in case of a claim under the System Warranty. The 5-year warranty period and the 10-year System Warranty are collectively referred to as the "Warranty Period".





#### 3. Validity of the Warranty

The Warranty is valid for Products manufactured after 01.06.2024 and the Products must be installed by a professional installer.

The Warranty shall become effective only with an installer invoice clearly specifying the Products. For the System Warranty it is further required that the professional installer installing the Products fills-in and signs Annex 1.

This Warranty applies only to the first original end-user customer and is subject to the terms and requirements described herein. This Warranty is non-transferable.

## 4. How to make a claim under the Warranty

All claims under this Warranty must be made in writing.

Claims, together with proof of installation by professional installer (installer invoice) and special warranty extension document copy (i.e. Annex 1, when applies), must be made to the installer without undue delay and must be received by the installer no later than 30 days after discovery of a defect.

Danfoss may request you to forward the defective Product to us via the installer with a written notice describing the reason for returning the Product. Products returned or made available for repair shall be free of extraneous equipment, unless otherwise instructed. If Danfoss' examination shows that the Product is not defective, Danfoss may return the Product to you at your cost and risk.

#### 5. Scope of warranty

During the Warranty Period Danfoss will at its discretion offer a new, comparable replacement product, or repair the Product, if the Product is defective due to defects in design, material or workmanship and the fault lies with Danfoss.

The Warranty does not cover any costs related to installation or handling, such as demounting of the defective Products or mounting of a replacement products or repaired Product. Batteries are not covered by the Warranty.

#### 6. Limitations and exceptions from the warranty

This Warranty does not apply to defects

- which occur under conditions of operations other than the conditions stipulated in the technical specifications and the instructions;
- which are caused by your failure to implement all software bug fixes or software error fixes;
- which are caused by software bugs or errors significantly impeding the use of the Product, provided that Danfoss releases a software bug or error fix within a reasonable time;
- which result from improper use;
- which result from faulty installation; or
- which were caused by faulty maintenance.

If Danfoss or a third party instructed by Danfoss investigates or repairs a defect that is not covered by this Warranty, the time and material used by Danfoss to this end may be invoiced unless Danfoss is obliged to assume such costs for other legal reasons.

## 7. Disputes and law

Disputes between the owner of the products and Danfoss regarding this extended warranty must be handled by the Court in Sønderborg, Denmark, under Danish law.
