V	Warranty	This limited warranty is granted by the Danfoss selling legal entity, being an entity directly or indirectly controlled by Danfoss A/S whether by shares or voting rights (referred to herein as "Danfoss"). Danfoss warrant to the party (referred to herein as "Buyer") purchasing a new Danfoss Power Solutions product from Danfoss that the purchased product will be free from defects in design, material, and workmanship for the applicable Warranty Period, as defined below.

		The duration of Danfoss' limited warranty for each product purchased is printed below in the section titled Warranty Period (referred to herein as the "Warranty Period"). Danfoss shall, at its sole option, repair or replace products or parts found by Danfoss to be defective in design, material or workmanship during the applicable Warranty Period, or in its sole discretion issue a refund credit for the purchase price paid by Buyer for such products or parts, provided that Danfoss is promptly advised in writing of Buyer's warranty claim within the applicable Warranty Period and the product or part in question is made available for inspection by Danfoss upon request.

If requested, Buyer will promptly return the product or part to Danfoss' Authorized Service Center or Factory Repair Facility (each referred to herein as a "Service Center"), as directed by Danfoss, free of extraneous equipment unless otherwise instructed.

- Failure to use genuine Danfoss parts in any repairs;
- Failure to follow Danfoss' printed instructions for operation or maintenance;
- Use of Danfoss hoses, fittings, and connectors with fluid conveyance products not sold by Danfoss; and/or
- Assembly of Danfoss hoses, fittings, and connectors with crimping machines, dies, or swaging tools not sold by Danfoss.

- (i) 24 consecutive months from the date of first use of the product, or
- (ii) 36 consecutive months from the date of original manufacture of the product from Danfoss.

质保期始于产品出厂之日起,至以下两者中较早者为止:

Rebuilt products (products and subassemblies rebuilt at a Service Center)

If a product (new or select) is rebuilt at a Service Center during the original new product Warranty Period, Danfoss' limited warranty on the rebuilt item shall continue from the completion of rebuild for the remainder of the original new product Warranty Period, or for a period equal to 50% of the original new product Warranty Period, whichever period ends later.
